THE GHANA CSO PLATFORM ANNOUNCES CHANGES IN ITS LEADERSHIP

Accra, 29th November 2024 – The Ghana CSOs Platform on SDGs successfully held a handingover and induction ceremony for its newly elected Co-Chairs and Steering Committee at the UNDP Conference Room in Accra. The event marks a significant milestone in the Platform's journey to strengthen civil society coordination in achieving the Sustainable Development Goals (SDGs) in Ghana.

This ceremony followed the Platform's Annual General Assembly decision on 21st December 2023 to organize new elections for all its Sub-Platforms. The rigorous election process, which began in January 2024, concluded in October 2024, with 16 out of the 18 National Sub-Platforms and 12 out of the 16 District Platforms successfully electing new leaders.
